Shared report for June, thanked J Pehrson for recent donation and sponsorship. Allen Inst, also made donation. Proceeds over \$2,000. No unusual transactions. Year-to-date, balance increased by \$5,459. Von asked about restricted funds which are for website updates, \$1,357 still remaining.

4. Determine Board's ST3 position

Matt provided some context in preparation for giving public testimony at the July 27 Sound Transit (ST) Board meeting. SLUCC has been engaged in this effort since 2010 and involved in identifying station locations since 2014. The outcome was that there would be 2 stations.

Jane Zalutsky, ED Seattle Center Fdn has been involved for many years in this process and is also involved in the Mercer Stakeholders group. Jane shared, ST is trying to produce an on time/on budget project, but up against various constraints. There are currently 3 options being considered; 2 proposals with 2 stops in SLU and one that includes just one stop. ST Board is considering a vote to change preferred alternative to potentially consolidation of 2 stations/elimination of one station. A committee meets this week to make a recommendation stops and board is scheduled to vote at end of month.

Debi Fausto (in attendance), representing Uptown Alliance is in agreement that 2 stations need to be in SLU This has been apparent through their own studies related to zoning and future growth. They have started petition to save the station - 180 signatures in just a few days.

Questions:

What will be the impact on data on ridership? Most studies have just been based on peak ridership not event surges. We don't know if they will use information provided by Climate Pledge to inform decisions. Debi Fausto expressed that Uptown would like to stay in step with SUCC

What about a station west of Dexter? Matt said they are not interested in exploring locations west of 7th currently. Some interest in location closest the east side of Seattle Center, but that takes you farther from Sound Transit.
