

- Neighborhoods remain vital and attractive places to visit, live, and have access to businesses


Mission:

  - Keep people and goods moving





Construction Management Plan (CMP)

- Required as a condition of SDCI's Master Use Permit (MUP)
  when SEPA is triggered
- SDOT reviews the following:
  - Notification and outreach
  - Contractor parking
  - High level ROW impacts
  - Coordination requirements
  - Haul route



#### Preliminary ROW Assessment Meeting (PRAM)

#### Project specific ROW management coaching


- ROW impacts per phase of construction
- Access (peds, bikes & businesses)
- Outreach, notification and on-site signage
- Long term parking & curb space
- Contractor parking
- Adjacent and opposite coordination
- Other agency coordination

#### Permit coaching

- Application & plan requirements
- Expected timelines
- Resources



### Active construction




3 Week Look Ahead Spreadsheet (3WLA)

- 1-2 weeks: actual ROW impacts
- 2-3 weeks: requested ROW impacts
- Identifies potential conflicts
- Internal and external reference
- Major event schedule included




- Notification and outreach
